



NOTIFICATION

This is notified for general information that following modification in the form of '**CORRIGENDUM / ADDENDUM**' have been made in the Rules and Regulations for Credit Based Six Semesters BA / B.Sc. / B.Com (TDP and TDP(H) Degree Programme as notified vide No. F.TU/REG/ Ac/ UG/03/07(Vol-II) dated 22nd August, 2014 :

"CORRIGENDUM"

1. Please read the title as "**RULES & REGULATIONS OF CHOICE AND CREDIT-BASED SIX-SEMESTERS B.A./B.SC./B.COM (GENERAL AND HONOURS)**" instead of "**RULES AND REGULATIONS OF CREDIT BASED SIX SEMESER DEGREE PROGRAMME OF B.A./B.SC./B.COM (GENERAL AND HONOURS)**" as appeared in the top of the first page of the Notification.
2. **Para 1.1(i) be substituted with the following para :**
" These Regulations shall be called " The Regulations of Choice and Credit Based Six Semester Degree Programme of BA/B.Sc./B.Com (General and Honours)."
3. **Para 4.2 be substituted with the following para :**
"Internal Evaluation shall be based on atleast two sessional examinations and Seminar/Group Discussion etc. and the sum of best two performance of the same will be the marks of Internal assessment of any particular course (paper)".
4. **Para 7.4 be substituted with the following para :**
"A student will be eligible to appear as a student in the End-Semester Examination of the University if he / she secures atleast 40% marks (i.e. 8 marks) in the Internal Assessment portion of each subject. That is, **no student will be allowed to appear in the End-Semester Examination of the University if he/she fails to secure minimum 40% marks in the Internal Assessment portion of each subject.**"
5. **Rules 3 of Annexure-III be substituted with the following para :**
"If a student misses any sessional examination for unavoidable reason or fails to secure 40% marks in the sessional examination in any course, the concerned teacher may allow the student to appear in a separate examination at his/her own discretion."

“ADDENDUM”

1. ‘Disaster management’ shall be included in the list of Soft Study courses in **Annexure-II.**

2. **Following Sub-Para 2.3(e) be inserted after 2.3(d) :**


“(e). Students who secure grade B+ and above in a general course of 1st Semester be allowed to take Honours in that particular subject from 2nd Semester onwards. However, this will be subject to availability of vacant seats in the respective college in that subject.”

3. **Following Para be inserted as Sub-Para (g) after Sub-Para (f) under Para 13 :**

“(g). Student who appears as a Honours student in the 1st Semester but fails in the Honours paper or who fails in the 1st semester as a whole or declared as qualified with or without back paper for the 2nd semester be allowed to continue his/her studies as a student under General Programme and appear at the examination accordingly and in such cases the Honours subject be treated as general subject.”


These modifications shall be deemed to have been come into effect from the Academic Session 2014-2015.
